IRS Information

Beginning in 2008, some organizations in the United States that were not required to file tax returns with the Internal Revenue Service (IRS) - including Kiwanis clubs - will have a new filing requirement: the new electronic postcard Form 990-N.

Small, tax-exempt organizations whose gross receipts normally are \$25,000 or less are not required to file IRS forms 990 or 990-EZ. But the Pension Protection Act of 2006 requires these organizations to file the new electronic form annually. Failure to file for three consecutive years could result in revocation of the organization's tax-exempt status.

The standard information the IRS will require when filing the electronic Form 990-N is the name of your Kiwanis club, mailing address, Web site address (if applicable), employer identification number (EIN), annual tax period date, and a statement that annual gross receipts are still normally \$25,000 or less. Because Kiwanis International operates on a fiscal year (October 1-September 30), the first filing will be for the tax period that begins October 1, 2007 and ends September 30, 2008, with a filing due date of February 15, 2009

Many Kiwanis clubs may already have received a notice from the IRS regarding this new requirement. If your club hasn't been notified, refer to the IRS Web site to see if the new ruling applies to your club.

Kiwanis Int'l Proposes Major Revenue Changes in Nashville

Like many nonprofits, Kiwanis International has been examining its revenue sources to determine how it can better leverage its resources to achieve organizational growth and service objectives. As a Kiwanis International Trustee and as a member of the Revenue Task Force created over a year ago headed by International Trustee Don Sanker, I have been advancing certain ideas which the Kiwanis International Board approved in October for presentation to the House of Delegates in Nashville in June 2009.

Here are just three of the important initiatives for our members to consider and approve in Nashville:

1) Elimination of the New Member Add Fee: The term "Add Fee" has a terribly negative connotation and is perceived as a immediate "penalty" on recruitment. Moreover, the manner in which Kiwanis has collected this fee in the context of the three-part billing cycle has seriously impaired prompt reporting and enrollment of new members. It has also created havoc on the calculations needed for awards incentives. The KI Board is recommending that the "add fee" be replaced by a "New Member Enrollment Fee." The fee will be a "graduated" enrollment fee based on an established rate schedule when the new member enrolls. The fee will not exceed the current per member charge of \$62 for the total of dues, magazine, and insurance.

2) Establishing One Common Annual Billing Cycle: In preparation for a new online billing system to be initiated in 2010-11, the threegroup billing cycle will be replaced with one annual billing based on the number of members reported as of midnight September 30. To facilitate the transition for clubs currently in the Groups 2 and 3 cycles, a reasonable payment deferral system will be enacted to phase-in the

transition so as not to harm club finances and cashflow.

3) Replacing the word "Dues" in the Kiwanis International Bylaws with the term "Annual Club Fee": Contrary to what most members believe, members do not pay dues to Kiwanis International nor do they pay dues to their Districts. They are members of clubs to which they remit club dues. By remitting club dues, they do not become members of Kiwanis International or District. Members owe their primary loyalty to support the financing of their clubs and the members themselves decide the amount of their club dues. Kiwanis Clubs are "members" of Kiwanis International and the Districts in which they reside. To make this distinction clearer, the KI Board is proposing to change the wording in the International Bylaws to state that clubs in good standing are levied an "Annual Club Fee" based on the number of members reported in each club by midnight on September 30. The cost of this Fee will be no more than \$62 for each reported member, the current combined total of dues (\$42), magazine (\$8) and insurance (\$12).

With the implementation of online billing and "real-time maintenance" of club data, Ki-wanis International believes these changes, including the reconfiguration of dues, magazine, and insurance into one annual club fee along with the eventual elimination of individual "dues waivers", will lead to a more effective and less cumbersome revenue collection process.

Anticipating that there will be many questions, I will be discussing these and other changes at a special forum to be held at the New York District Mid-Year conference on Saturday morning February 21. I hope many will attend to seek further clarification and understanding of the importance of these changes to improve the efficiency of our Kiwanis organization.



E-mail – Internal and External Communication

First Impressions Count! Communicating Effectively via E-mail. Writing and sending email messages is easy; crafting effective messages, on the other hand, can be a challenge. You need to make sure your message not only says what you want it to say, but that it also conveys the right impression. E-mail messages are useful as a club newsletter communication, updates to members, and most of all are used to convey our messages to the media for publication.

An e-mail full of misspelled words or typos can give the media or fellow Kiwanian the impression that you're careless, and an angry message sent in haste can jeopardize a relationship that took years to build. Knowing the limitations of e-mail can help prevent these kinds of disasters.

Grammar. All kinds of rules are broken in e-mail. Capitalization disappears. Fragments run rampant. When sending to the media, don't break those rules! Don't forget that the recipient evaluates you based on your message. Try to remember to dot your i's and cross your t's.

Spelling. Most e-mail programs offer some type of spell-check function. Use it. You want your words to carry weight, not to highlight your inattention to detail.

Tone. It's much harder to gauge tone in email than in conversation. Remember that your recipient won't have the benefit of the cues they would have in conversation. They can't see you wink or hear you laugh, and the ironic sentiment you mean to convey might be misconstrued. This doesn't mean you need to write form letters, but be careful.

Emoticons. Although "smileys" "emoticons" have become hallmarks of online communication, they're usually inappropriate in business correspondence. Emoticons are not appropriate in a press release, for example, but are most effective in internal communication with your membership.

Signature. If you use a preformatted email signature with your contact information, be sure to type your name at the end of your message as well. Relying on the signature in lieu of your name can be construed as cold and impersonal.

Subject headers. Providing an accurate subject header is essential. Many people choose what to open based on the subject line; blank subject lines or subjects that have little to do with the message contents are frustrating for the reader. Include name of club when sending to the media or even to the ESK.

Think twice. Always reread your outgoing messages before you send them especially if you're angry. E-mail makes it easy to fire off a message you might regret later. Take a deep breath and reread the Continued on Page 10






BROOKLYN DIVISION


The festive party was held at the base in Fort Hamilton, Brooklyn. Everyone including the service members, children and Kiwanians enjoyed themselves.





There are many clubs looking for a simple – quick fix to accomplish their Community Services for the year.

One of the simplest – quick – low manpower with high results is running a empty FOOD CART display outside the local King Kullen – Walmarts or Stop & Shop.

Simply - have your club Community Service chairperson approach the store Manager three weeks before your planned Saturday [one time] collection.

There are at least four different times during the year that this is useful and necessary. The Saturday before Christmas, Thanksgiving, Easter or other special day that you determine are the most successful.

The store will supply the empty food carts which are placed in front of the store – Be careful not to block store access or you will lose a friend in the Manager.

Print flyers and hand them to the incoming customers of the store — 'asking them to BUY ONE MORE CAN OF ANY FOOD STUFF — and leave it with you when they leave the store — Be sure to identify the beneficiary of your work — which Pantry will get the Food or will it be the local Salvation Army which is usually well received.

Our club in Mineola began some years back with this idea and filled two carts. Last year we filled seven carts and could have had more - BUYING ONE CAN is not a burden on shoppers - Multiply the shoppers on any given Saturday and you will be very surprised - You need three or four volunteers who could work two hour shifts from 8am to 6pm..

Have flyers handy – tell the shoppers who you are, and who will be getting the benefit of your gifts - SIMPLE AND QUICK FIX - no gamble involved – TRY IT !!!!

Be sure to have your Kiwanis club sign prominently displayed and your members recognized with proper identification - Good luck !!!

How is your Builders Club doing?

It is more important than ever to make sure that your Kiwanis Club is involved with your Builders Club; and, that your Kiwanis Club's Builders Club advisor is in contact with your Builders Club Faculty advisor. Anytime of the school year is an extremely busy time for any school teacher. Taking on the role of advisor to a Builders Club makes it even more so. Anything your club can do to help get the Builders Club going and keep it active, can take a tremendous burden off their Faculty advisor. Your Kiwanis Advisor could offer to help facilitate a Builders Club meeting or project. Hopefully you have trained the Builders Club's new officers in how to run a meeting (who does it, parliamentary procedures, agendas, etc.) and by just being at the meetings, in case the officer has a problem remembering how to do it, is a tremendous help. It is in your club's best interest to see that your Builders Club is successful this year and every year.

Kiwanis has implemented a change to the builders Club fee structure this year. Beginning in October of 2008, each Builders Club was assessed an annual club fee of \$150 instead of the previous amount based upon how many members the club had. This \$150 was billed to the sponsoring Kiwanis Club. This new system replaces the old system where the individual Builders Club members had to pay the membership fee. Under this new system, the club can have any number of members and not have to go through the process of collecting from each one, dropping members from the club roster and adding new members during the year.

One important side effect of this new structure is that the Kiwanis Club really must be in contact with the Builders Club or at least the Builders Club Faculty advisor. In the past, some Kiwanis Clubs have chartered a Builders Club and just let it be. When the Builders Club had problems, they were not comfortable coming to the Kiwanis sponsoring club, as they really had not developed any kind of relationship with Kiwanis and were not sure what Kiwanis could do. Your Builders Club is a wealth of opportunity for your club to help develop young leaders; to give Middle School aged children an opportunity to develop self esteem by not only working on their own projects but by helping your Kiwanis club with its projects; and, to spread the name and multiply the service Kiwanis does in your community.

When your club pays the Builders Club dues, you complete a form that asks where the materials (Membership cards, certificates, pins, etc.) are to be sent. If you have them sent to your Kiwanis Advisor, it is the perfect opportunity to have Kiwanis members attend a Builders Club meeting and give these to the Builders Club members. 

Lyme Disease

In the next ESK I will describe the Symptoms of Lyme Disease.

How Lyme Disease Became Known

Lyme disease was first recognized in 1975 after researchers investigated why unusually large numbers of children were being diagnosed with juvenile rheumatoid arthritis in Lyme, Connecticut, and two neighboring towns. The researchers discovered that most of the affected children lived and played near wooded areas where ticks live. They also found that the children's first symptoms typically started in the summer months, the height of the tick season. Several of the patients interviewed reported having a skin rash just before developing their arthritis. Many also recalled being bitten by a tick at the rash site.

Further investigation discovered that tiny deer ticks infected with a spiral-shaped bacterium or spirochete (which was later named Borrelia burgdorferi) were responsible for the outbreak of arthtitis in Lyme.

In Europe, a skin rash similar to that of lyme disease had been described in medical literature dating back to the turn of the 20th century. Lyme disease may have spread from Europe to the United States in the early 1900s, but health experts only recently recognized it as a distinct illness. Small rodents and deer play an important role in a deer tick's life cycle.

Both nymphs and adult ticks can transmit Lyme disease, causing bacteria. The increase of the deer population in the Northeast and of housing developments in rural areas where deer ticks are commonly found probably contribute to the disease's increased spread. Lyme disease has been reported in nearly all states in the United States, although more than 95 percent of all reported cases are concentrated in the Northeast, mid-Atlantic states, Wisconsin, Minnesota, and northern California. Lyme disease is also found in large areas of Asia and Europe.

Deer ticks lay eggs that turn into larvae that feed on mice and other small mammals. The larvae then develop into immature ticks called nymphs. The nymphs then feed on small mammals and humans. Adult deer ticks usually feed on deer during the adult part of their life cycles.



Elmira Aktion Club Seeks Opportunities to Give Back

One of the great things about working for a newspaper for a long time, maybe the greatest thing, is the regular cast of characters you get to know.

They're the people you keep running into while out on assignment or looking for things to write about. One of the hardest parts of leaving the newspaper was falling out of contact with some of those ordinary folks who kept turning up.

Among my favorites was Eric Lindsay, the guy who moved to Elmira, then realized he looked just like Mark Twain. I'd only written about Eric once or twice, but we bumped into each other a dozen times over the last few years. I always enjoyed finding Chemung County Historian Archie Kieffer in unexpected places. Archie, with his informal, encyclopedic knowledge of the way things used to be, is one of the Twin Tiers' greatest treasures.

But maybe my happiest unexpected meetings were with Peggy Eastburn. I'd find Peggy often at St. Joseph's Hospital in Elmira when I visited there to cover events. Peggy was a volunteer there for some time and has volunteered in other ways around Elmira. For me, her irrepressible cheerfulness has always been an uplifting bonus to working at the paper.

Peggy finds ways to contribute to the community despite her disability, which restricts her to a motorized wheelchair and to limited use of her hands and arms. It doesn't restrict her quick mind or her friendly voice. She is a natural organizer and motivator, is politically minded (an Eric Massa election bumper sticker adorns her wheelchair) and has a drive to contribute.

The wonderful thing about Peggy is she is not alone. Wednesday night, I had the pleasure of meeting her colleagues with the Aktion Club of Elmira. It's made up of people with physical or developmental disabilities brought together by their sincere desire to

help others. Led by a board of directors from their own ranks -- Tim Tompkins is president this year -- the group seeks opportunities to give back to the communities that have helped care for them.

Most members are residents of homes operated by Chemung ARC, the Cerebral Palsy and Handicapped Children's Association of Chemung County and other agencies. Others are disabled community members living on their own. They are advised by representatives from the agencies who assist people with disabilities and sponsored by the Elmira Kiwanis Club.

Ennis, EMT Director, Public Health Education Dept. of Professional & Public Health Education Director, New York State Safe Kids Coalitions and Chapters presented Key Club attendees with a Trainer's Guide at the Injury Prevention/ Safety Education Day held December 2008, sponsored by the Nassau County Safe Kids Coalition and the Kiwanis Pediateric Trauma Center, Schneider Children's Hospital at North Shore.

Director for the NYS Safe Kids Coalitions and Chapters Rosemarie Ennis welcomed guests to the first New York State Key Club Injury Prevention / Safety Education Day. She offered, "Listen closely to today's presenters, read your Trainer's Guide and spread today's message and information within your home town. Consider becoming involved within your county and local community in keeping our State's young citizens safe."

Through the combined efforts of our State's Safe Kids Coalitions and Chapters and their members (hospitals, government agencies, corporations, public health and advocacy organizations, private groups and community citizens), New York State has seen remarkable achievements in preventing and reducing childhood injuries and deaths due to preventable accidents.

From 1985 to 2000, there has been 55.3% decline of unintentional injury/death rate among children ages 14 and under in New York State - one of the most dramatic declines ever seen in a children's health issue. However, despite this tremendous progress, accidental injury remains the number one killer in young children in the United States today. These facts underscore both the value of what we have done and the need to continue doing what we do - educate adults and children, create environments, conduct research advocate for effective laws for our young. Every New York State resident has a role to play in helping to prevent all types of accidental childhood injuries.




The remaining \$125 was donated through the brick program. The K-kids are proud to have their club placed on the wall of Governor's Hall.

K-kids Members Nicole and Julianne count coins collected for Kamp Kiwanis


FDN President Sal's Daughter Becomes A New York Times Best-Selling Author
