Hixson challenge match to end six months early – IDD Campaign success continues

Indianapolis, Indiana - If you're going to make a contribution to the Worldwide Service Project (WSP) under the Kiwanis International Foundation's Mel and Mary Cowart Challenge Match program, you'd better hurry. Because of an overwhelming global response, the program will end on March 31, six months ahead of schedule. Although the match offer will conclude at the end of the month, the Worldwide Service Project Campaign Cabinet will continue to seek contributions. Under the program, announced at this past summer's Kiwanis International convention, Kiwanis-family clubs and members contributing a minimum of \$500 to the fight against iodine deficiency disorders (IDD) have had their contributions matched. The donation and the program's matching funds then add up to qualify the donor for enrollment in the George F. Hixson Fellowship. The Cowarts initiated the Hixson match program

with a lead gift of \$300,000. In addition to their gift, several other Kiwanians committed major gifts to the campaign to be used as matching funds. Those individuals who gave \$25,000 or more qualified as a "Pacesetter" for the campaign.

Since its July 2004 launch, more than 2,200 people or clubs have applied for matching Hixsons under the program, which equates to more than \$1.1 million raised for the initiative to virtually eliminate IDD around the globe.
