



Before long, this band started playing not only adequate music or good music, but great music. Because of their amazing musical skill and broad repertoire, including over 100 songs from Pink Floyd to Gershwin, FLAME has had hundreds of paid performances throughout New York State, into New Jersey and Washington, D.C. Everywhere the band plays, their extraordinary music thrills and inspires audiences, including people with disabilities and their families.














New Member Orientation Peter J. Owens

From the last monthly statistics from the dis-

trict, we do not appear to be doing New Member orientation. The report indicated that with over 300

clubs in the District, we only managed to effect a net change of twelve new members. That increase is not even divisible by the overall number of clubs.

We try to make a change 'one child at a time.' Why can't we make a change 'one member at a time'? If every club decided this quarter to develop plans to get only one new member, regardless of the size of the club, we should have close to 300 new members - one person at a time. If you look at the materials that Kiwanis and the District have provided for our officers, you will see an excellent path to obtain new members.

Why not schedule a New Member Orientation function in the spring? There is no doubt that with the effort, you will get that one new member. Governor Dave is halfway through his term and so are you.

If the club is showing minus, take the small step. If we all agree to get on new member this quarter, great things can happen. I think Kiwanis deserves that, don't you?





When Kiwanians visit with a K-Kids, Builders Club, Kiwanis Junior, Aktion Club, Key Club or Circle K, they demonstrate an interest in the activities of sponsored youth groups as well.

Some incentives for interclub activities are needed for a well rounded promotion by the Committee on Club Meeting. A successful interclub campaign leads to greater interest in the home club through specific, meaningful programs. As word of a terrific experience begins to circulate, more members will be inspired to create more interclubs.

Past club, division and district officers can be urged to remain active in Kiwanis by participating in interclub meetings. Through interclubs, a strong club can counsel and inspire clubs in their division not to fall below charter strength. Each club should prepare an interclub membership roster and record participation of club members at interclub meetings. Furthermore, the District Secretary, Lieutenant Governors and Chairmen of District Committees on club meetings, know about existing incentives and can help develop programs where none exist.

Between now and July 20 you have time to either start a site, or make sure yours is in the best position it can be, to be a winner. Once again, this year the sites will be judged by webmasters from other Kiwanis districts in North America.

- Here are the judging criteria:
- 1. Is the site up to date? Are there any outof-date references? Are new and upcoming events listed?
- 2. Does the club/division have its own domain name?
- 3. Is a link to the Kiwanis International web site featured?
- 4. Does the site include information of interest to non-members?
- 5. Does the site include information of interest to club members?
- 6. Do the links on the site work properly? Is the navigation easy follow? Are graphics displayed properly?
- 7. How strong is the site's overall impression on a visitor?

Each category will be worth 10 points.

To prepare for the contest, evaluate your site against the above criteria. In the past, the major problem with club sites has been that they are not kept up to date, so make sure yours has the latest information. Outdated information should be removed.

You also can take a look at the listing of all club web sites, also included on the District web site, so that you can evaluate the competition and pick up ideas for how to make your club's or division's site better.

There will be one award for the best division web site, and three awards for club web sites. Winners will be honored at the District Convention in September and have their sites featured on the District web site.

Past Gov Tony Palangi Proclaimed Circle K Convention Honoree Again

2006 CIRCLE K CONVENTION - PG Anthony Palangi became the first person in Circle K history to be Convention Honoree twice. The first time, he became Convention Honoree was 1986. Since then, Palangi has continued to be an amazing support system and advocate for many Circle K'ers. It seems appropriate that they re-honor such an amazing and dedicated individual again twenty years later.

Palangi migrated to America in 1929 from Moccasicura, Italy. He attended St. Mary's High School in Glens Falls and moved onto Skidmore College in Saratoga Springs before studying at the American Conservatory of Music as a Violinist.

Palangi was in the United States Air Force and served in World War II (Asiatic Pacific Theater) and the Korean War. He was awarded the Asiatic Pacific medal with two Bronze stars, the Philippine Liberation medal, the New York State Medal of Merit, the American Campaign Medal, and the Efficiency Honor and Fidelity Medal for his efforts and service. He is currently a member of the Veterans of Foreign Wars.

Palangi worked as a General Manager for the Saxton Manufacturing Corp. for thirtytwo years and created wall clocks. He is still continuing to make clocks in his retirement and each year honors the outgoing Kiwanis Governor with an original "Tony" clock.

Palangi joined the Kiwanis Club of Glens Falls in 1966 and has 38 years of perfect attendance at meetings. He was honored as a Distinguished Club President 1972-73. He served as the Lieutenant Governor for the Mohawk Division in 1975-76 and then as the New York Kiwanis Governor from 1983-84. He has been the Sponsored Youth Chairman and a Kiwanis Advisor since 1975 and has been involved with the Kiwanis Foundation Board since 1983.







Thanks to the Hewlett Peninsula Club once again for an additional donation of \$5,000 towards the Dominick Sciarrota infirmary.




