

Now that the International Convention in Montreal is completed, it is proper that I report to you some of what went on at the Convention. It was reported that at the Convention 4,340 members and 1,227 guests were in attendance. Of the Kiwanians 2,963 received delegate credentials, and 614 were named delegates at large. This made a total delegate count of 3,577 delegates. New York District registered 321 Kiwanians and guests. This was the fourth largest group at the Convention exceeded only by California Nevada Hawaii, Eastern Canada & the Caribbean and Florida. All agreed that it was a very good showing from New York.

There were three (3) Amendments that were passed by the Delegate body. The delegate body also passed one Resolution on behalf of Kiwanians around the world. That was, to endorse the goal of one million members by the Kiwanis Centennial year of 2015. See page 3 - Delegates Endorse member Goal article for specific details.

President Elect Nelson Tucker made the following appointments of interest to New York Kiwanians.

New York Trustee Tom DeJulio was assigned to serve as Counselor to the France-Monaco District, the New Jersey District, and to Circle K International.

Trustee Paul Palazzolo from the Illinois District was named Counselor to the New York District.

In other matters at the Convention, Gov. David Rothman was very pleased with the attendance at the New York breakfast. He stated that it was a "grand affair" even at 7:00 o'clock in the morning. Thanks to all who made this event such a success.

We have much to be proud of in the New York District, at the Key Club International Convention in Boston July 1 - 5, 2006 three New York Key Clubbers were elected to International offices including; Shivani Radhakrishnan from Minisink Valley Central School as International President, and elected as International Trustees were Mary Phillips from Jamesville - DeWitt High School, and Katrina Roehrig from Riverhead High School. Our congratulations go out to them as they begin their administrative duties.

The District Convention is just around the corner. It will be held from September 6-10, 2006 in Saratoga Springs NY. Each club in good standing (no outstanding dues) is allowed three (3) delegates and three (3) alternates at the convention. Delegate forms were mailed July 28, 2006 to the club Secretaries. Additional copies may be obtained from the District Office. The completed forms be returned to the District Office no later than August 25, 2006 The Convention promises to be well attended so early registration is necessary to ensure placement in the Headquarters Hotel-The Saratoga. BY-LAW AMENDMENT**

The following proposed amendment will be brought before the House of Delegates at the 2006 District Convention in Saratoga.

Language to be added is in bold face type. Language to be deleted is in parenthesis.

**PROPOSED AMENDMENT**

Submitted by: the 2005-2006 Finance Committee

Purpose: To increase the dues each member club must pay to the District for each of its members from \$19.50 to \$25.50.

**Article XV REVENUE**

Section 1. Each member club shall pay to the District for each of its members, with the exception of its honorary members, **\$25.50** (\$19.50) per annum as dues and \$4.50 per annum as a reimbursement contribution to the district foundation for its cost in issuing the Foundation Bulletin named Empire State Kiwanian, such amounts to include all District Charges, other than the registration fees paid by those in attendance at district convention, council or conferences. The total amount of **\$30.00** (\$24.00) per member shall be payable annually on the club's anniversary date as set forth in the International By-Laws.



- Region I (United States) Trustees: A. **Alan Penn** of the Medina Breakfast, Ohio, club; **Donald J. Sanker** of the Penn Hills, Pennsylvania, club; and **Stan L. Storey** of the Arlington, Jacksonville, Florida, club.

- Region II (Eastern Canada and the Caribbean District and Western Canada District) Trustee: Roy S. Bird, of the Edmonton, Alberta, club, was elected to this three-year term at the Western Canada District Convention in August 2005.

- Region III (Europe) Trustee: Theodor "Theo" Riesen of the Bern-Aare, Switzerland, club, was elected to this three-year term at the Kiwanis International-European Federation Convention this past May.

## Delegates Endorse Member Goal

Kiwanis will have 1 million members before its 100th birthday on January 21, 2015.

The goal is written into Kiwanis International's strategic plan, and it is the target on which North American, European, Asia-Pacific, and Latin American regional strategies focus. Now, Kiwanis clubs have expressed support of the membership goal too.

Representatives from clubs worldwide, participating in the House of Delegates at the 91st International Convention in Montréal, Québec, endorsed the 1-million-members goal with the passage of a resolution titled "One Million Members by 2015."

The resolution notes that Kiwanis volunteers are changing the world one child and one community at a time and that the strength and effectiveness of this service depends on the strength and effectiveness of the organization's membership. "To change the world by serving more children and more communities, Kiwanis membership must grow to meet tomorrow's needs," the resolution states.

According to Kiwanis International's strategic plan, the organization emphasizes three routes to its 1-million-members destination: Build on the current Kiwanis, adding members and enhancing traditional-style clubs; expand into communities and nations where Kiwanis is under-represented or does not yet exist; and explore new styles of clubs and memberships.

Delegates backed up the resolution with their approval of a Bylaws amendment, which grants a one-year dues reprieve for news members for clubs that experience membership gains of 25 percent or higher.

"This is the new type of thinking that will help Kiwanis achieve its 1 million-members goal by January 2015," says International President Steve Siemens of the proposal submitted by the Kiwanis Club of Alpine, Rockford, Illinois.

Other actions and decisions during the House of Delegates:

### Approved:

- An amendment to change the office of International Vice-President/Treasurer to Vice-President.

- An amendment to expand the definition of conduct unbecoming a member of the Kiwanis International Board to all Kiwanis International officers, including district governors.

### Failed:

- A proposal to allow flexibility in the composition of club boards of directors by setting board size at 10 percent of a club's membership.

• A proposal to provide that the House of Delegates address any change in charter fees, new-member induction/processing fees, or any other financial encumbrance for any member club or active, privileged, or senior member.

### Failed for lack of a motion:

• A proposal to require clubs to pay a US\$30 new-member fee to Kiwanis International.

### Referred back to the International Board for further consideration:

• A proposal to allow Kiwanis International to pursue new membership initiatives, such as affiliate groups, to best ensure robust growth worldwide in support of the one-million-members goal.

### Withdrawn:

• A proposal to limit the eligibility of former members of Kiwanis International sponsored programs for the waiver of dues payments to Kiwanis International for the first two years of membership.

• A proposal to allow clubs to pay dues on behalf of "family units" rather than on behalf of individual members.

• A proposal to change the eligibility of Kiwanis International officers for reimbursement for travel and accommodation expenses for the annually conducted International Council and Convention.

## The "R" Word – Derogatory Slang

"re-tard" (r\_· tãrd') – to make slow or slower; to delay or impede the progress, course or event of." (Webster's New Collegiate Dictionary, ©1961 G. & C. Merriam Co.) Our nation's special education law, the IDEA, defines mental retardation as . . . "significantly subaverage general intellectual functioning, existing concurrently with deficits in adaptive behavior and manifested during the developmental period, that adversely affects a child's educational performance." [34 Code of Federal Regulations §300.7(c)(6)]

That out of the way, this article is not about the actual definition or origin of the word retard, or the term mental retardation. Rather it is about the derogatory way retard, (hereon referred to as the "R" word) is used as a slang word in everyday language to many people.

My son David was born on November 28, 1984. He suffered a lack of oxygen at the time of his birth, resulting in a chronic seizure disorder and mental retardation. At the age of five he was diagnosed as having profound

mental retardation. It was a heartbreaking diagnosis, more so even than the seizures he suffered from almost daily. One of the first things that came to my mind was that he would be called "R" the rest of his life. I was determined from that moment on to help change the minds of people about using the "R" word. David was a child with mental retardation, not a "R". It was a diagnosis of his intellectual and adaptive functions, not who he was. He was still a beautiful boy with brown curly hair, blue eyes and a sweet, crooked smile that would make anyone smile back at him.

It is disturbing enough that over the years the "R" word has been used to make fun of someone whose intelligence is less than what is considered normal, whether they have mental retardation or another learning disability. More so lately it is used as everyday slang by many people towards just about anyone. They use the "R" word without even thinking about it. I hear young children, teenagers, college students, adults, professionals, teachers and even my own family use the word every day. Comedians, actors and radio hosts use the "R" word to supposedly be funny. I'm not laughing!

My daughter, Katie, age 19, and I almost always bring it to the attention of the person using the "R" word that it is both hurtful and

offensive to us. We tell them briefly about David and ask them if they have ever known someone who has mental retardation, to personalize it for them. We then ask them to think twice about using it again. We do this not just for David, but for his friends, classmates and all persons who have mental retardation.

Our beloved David passed away on August 18, 1996 from a sudden illness. His courage, faith and unconditional love are daily reminders to us to live each day to the fullest and to show respect and compassion to those less fortunate.

"Great strides are continually being made to include children and adults with special needs in our schools and community. Let us welcome them with open minds and open hearts."- from David's eulogy, written by Mom.

I had the honor of meeting New York District First Lady Debra Fuchs at the Southwestern Division Governor's Visit. We talked about Debra's Partner's Project and shared our experiences about Debra's brother, Richard and my son, David.


We found out that we both hated when people use the word retard, we termed it the "R" word, and decided to write this article together.

## Pediatric Lyme Disease

### Did You Know?

These facts about Lyme Disease and other tick borne infections?

Across the globe, all types of media are reporting increasing problems with ticks and their diseases. All local reports suggested an increase of Lyme Disease in New York State and on Long Island.

Ticks can go unnoticed, because they are so small.

Ticks can carry and transmit several diseases at once.

Reported cases of tick-borne disease continue to rise in many states in the US and many countries across our earth.

Any person can be infected for weeks or months or years or a LIFETIME.

An infected person can experience combinations of symptoms. They can be few or many changes, subtle or strange effects, difficult or tolerable pain, painful, or sometimes even there is an absence of symptoms altogether. There can be various types of rashes or even no rashes at all.

Quick and effective treatment following a tick bite could prevent persistent infection. Find a good specialist.

Unidentified and untreated infections can progress indefinitely.

All diseases a tick can transmit can be difficult to diagnose.

Tests can be falsely negative, leaving infected persons undiagnosed.

When a tick bite results in sickness, symptoms of the infection can be varied and easily mistaken as other illnesses or diseases.

There are NO 100% conclusive, diagnostic tests for most of these infectious diseases.

There are very few doctors, tests, or labs able to diagnose 'Lyme' or associated tick-borne disease.

There are even less doctors treating Lyme and associated diseases.

Upon completion of 2 to 6 weeks or more of treatment, countless individuals continue experiencing symptoms and some continue testing positive for tick-borne diseases.

The reality of tick-borne diseases continues to be an enigma for scientists and doctors worldwide.

As you know, this program was started when I was Governor of this great district. We have come a long way since then. We are now a Foundation (Pediatric Lyme Disease Emergency Fund) and any donation is tax deductible. We now have two fundraisers. One is selling pins and the other, which has just been introduced, is called the Brittany Fellowship, which is named after the little girl who gave that moving speech at our district convention. A contribution of \$500 will get you enrolled as a Brittany Fellow. You will receive a medallion and plaque, which is numbered (*sorry, no jackets*). The first one,

The New Kiwanis will be redesigned and restructured to become more cost effective and efficient. Clubs and their members expect that and deserve nothing less. And they also expect to be empowered, not embarrassed, by Kiwanis activities. And that includes running a House of Delegates without confusion. The commitment to excellence was best demonstrated by the contrast between the Montreal experience and the "hula dances" done on the delegate floor in Hawaii last year when the amendment to the amendment that was first amended by an earlier amendment made by a point of order that was out of order at the wrong microphone could not be heard.

The New Kiwanis also believes that nothing of value happens in our organization in the absence of leadership, leadership that is committed in its vision, in its strategic planning, and in its management. Toward that end, because we believe better than 85% of our challenges, conflicts, and controversies are solvable through more education and better communication, the New Kiwanis is developing K-University, a broad based educational initiative to reach out beyond the relatively few who always come year after year to convention workshops and forums.

We need to reach out to all Kiwanians, all too many I fear are disconnected from their International and District structures. These are the members who labor in the fields of service of their local communities and who may not realize how much our organization needs their skills and talents in leadership positions in our regional and International structures.

The New Kiwanis will reach out to that untapped potential to assume club regional and district leadership roles so that "funny" story about the last person to arrive at a club meeting becomes next year's president will become fiction rather than common practice.

Yes the New Kiwanis CAN AND WILL DO IT - Climb Higher, Achieve Success and Nurture Excellence. But the new Kiwanis is not the bricks and mortar of a building in Indianapolis. The New Kiwanis is you.

You are the ones transforming lives daily by your volunteer spirit. You are the ones who by what you do, transform your own lives through the magic of Kiwanis service. You are the ones who love this organization so much, and all that it does collectively and all the time honored values it stands for, that you will not only continue in Kiwanis with your compassion and great heartedness, but you will also recognize that one of the most important responsibilities of your being a Kiwanian is to SHARE your love of Kiwanis by inviting others to join.

The New Kiwanis believes that membership growth is not a numbers game, (its not a game at all) but a serious desire to render more service in your community and in newly defined and more diverse communities who need Kiwanis and who are willing to go beyond random acts of kindness and make a commitment, a long term commitment to the Kiwanis brand of service.

I've written before about the late George H. Prout of the Troy Kiwanis Club, editor of our Empire State Kiwanian from 1931 until 1973 (yes that's 43 years!). George was named an Honorary PG of our NYD in 1963 and in my book he was a giant among giants during what many would regard as the golden age of Kiwanis in our district and you would look in vain for a more dedicated Kiwanian or a more gentle gentleman. I'm so grateful for having known him.

I have in my possession a photo album/ring binder which George Prout assembled and presented to our district "in appreciation of the privilege, it has been of knowing each of (the dedicated Kiwanians pictured) with the exception of (the first four district governors, who served from 1918 to 1922)." The album includes the official photographs of every one of the Kiwanians who served as NYDG, from the first Claren A. Nelson in 1918, through Richard J. 

- Participate in joint projects: Service projects, Fund Raisers, Kamp Kiwanis, and many other activities. Key Club and Circle K members are a very significant source of manpower.
- Financially support delegates to the District and International Conventions including the Kiwanis and Faculty Advisors.
- Include Key Club and Circle K members in your interclubs. Officially they can be a part of a Kiwanis interclub.

Make sure that your sponsored youth club has all the materials available from the International office to assist and guide them to a successful year of service and growth.

Most importantly, communicate and work together with the young people who look to us for guidance and support. It's our responsibility to help them become responsible citizens and future leaders of the country.

### Kiwanis Int'l Foundation

As we head towards the end of the 2005-06 Administrative year, I want to encourage all Clubs to contribute to the Annual Club Gift Campaign to support all of the worthwhile programs the Kiwanis International Foundations provides to us, if they have not done so already.

A contribution of \$100, or \$5 per member as of your 10/01/05 club membership not only earns your club a banner patch, but earns 10 points towards Distinguished Club status, which for most clubs is necessary to make the 80 point requirement by 09/30/06. The money goes to help our Sponsored Youth Programs, Grants (which we have qualified for in the past for the NY District Foundation and other Kiwanis Clubs), Kiwanis Disaster Relief and many educational programs.

For those clubs who have already contributed to the ACG Campaign, thank-you for the over \$12,700 donated through 07/15/06...which equates to \$1.35 per member in the NY District. Our goal is to average \$3.00 per member to gain District recognition (which has never been done before), so we have a long way to go! We need to get to about \$28,500.

Divisions could have a division fund raiser and proceeds could cover each club's contribution (by the criteria set above) so all clubs earn the 10 distinguished points. # PIP's Club Turns Fifty







## A FOND FAREWELL . . .



Bob was the true definition of a MENTOR. Bob mentored so many young people through our Key Clubs. Many of those that Bob mentored became leaders in Key Club, then Circle K and finally in Kiwanis. Through Bob's guidance and patience so many of these young people went on to have wonderful college experiences and set examples for the those who followed them. Mentoring is just that, reaching out and helping a young person become the best person they can be. Bob was a master at that. It was a true testament when so many of his past key clubbers paid their respects at his wake and funeral service. Many of them had a loss for words, but the tears that rolled down their faces told you how much Mr. Cummo meant to them. We hope you can find it within yourselves to follow Bob's example and become a mentor. As a former key clubber, Jenn Geiss, wrote about Bob Cummo, "In a world of negativity, there are people who rise above the pessimism that has befallen most. They share in a common hope and give selflessly of themselves." Let's not just say "We serve the children of the world" lets do it! Governor David remarked at Bob's wake, "We come here today to honor Bob's memory, to express to his family and friends our comforting wishes and to show our love for our departed friend and brother Kiwanian."




