## **Report of the International Trustee**

Growth

Pursuant to the "Flexibility Amendment" passed by the House of Delegates in San Antonio in 2007, KI has approved "piloting" two membership initiatives: Company-based Kiwanis clubs and Club Satellites.

#### **Company-based Kiwanis Clubs:**

A Kiwanis club can exist within a large business or company, paying an annual club "franchise" fee of \$2,500 for up to 35 members. Upon Board approval, Districts will receive one-third of this fee. Pilot company clubs are presently being formed at a large law firm in midtown Manhattan and at a Walmart Distribution Plant in Indianapolis. The Board sees company-based clubs as an opportunity to expand Kiwanis and its "house" brands of Service Leadership programs to a new audience of volunteers not bounded by or limited to a geographically defined community.

#### **Club Satellites:**

A Club Satellite can be opened in areas that may not be able to sustain a club of charter size. Members of Club Satellites can be added to the rosters of thriving "classic" Kiwanis clubs which serve as "host" to their one or more satellites established in schools. hospitals, other non-profit agencies, and other appropriate entities/locations. The Board also sees the potential for Club Satellites established in response to requests for charter revocation of small, struggling clubs (less than 10 members) whose members wish to retain their membership in Kiwanis but who may not be able to regularly travel to and actively participate in their host club meetings. The members of Club Satellites will be expected to pay the annual club dues established by their host Kiwanis club but are expected to continue to perform Kiwanis service within their own orbit of operation. Members of Club Satellites may have a common interest, community, hobby, or single-service focus (i.e., K-Kids or Key Club sponsorship). The Board sees Club Satellites as an opportunity to expand and/or retain a Kiwanis volunteer presence in more

#### Finance

Despite the declining stock market and significant loss of investment income, KI should end FY 08 with a surplus thanks

primarily to tighter budget controls, aggressive oversight by the Board's Finance Committee and its Independent Financial Advisor, staff reorganization, and significant savings in KI Board expenses. The Board also approved a balanced budget for FY09 with more than \$250,000 in new initiatives. As a member of the Finance Committee this year, I and the Board reviewed proposals presented to it by a special Revenue Task Force, headed by Trustee Don Sanker. The Board will be approving significant changes to the current dues structure and collection process which will require bylaw amendments to be presented at the Nashville 2009 convention. Likely included among them will be the elimination of the "new member ADD fee" to be replaced by pro-rata dues collection, and the restoration of the one fixed annual date for payment of International and District dues, to replace the current "three-part" dues collection process. I was invited to join this Revenue Task Force to provide continuity of service and advice in these important financial areas, as well as to develop recommendations for the KI Magazine Fund and International Convention Fund.

#### Leadership

The KI Leadership Development Committee which I chaired this past year began developing competency-based curriculum for all levels of Kiwanis leadership, including online training and E-learning opportunities. I have been invited by KI President Don Canaday to continue work in this area on the International level, supporting staff in its efforts to unveil these new tools and resources to Presidents-elect next Spring. Over the next two years, I was also asked to lead with Past Distinguished Governor Pat Hawkins of the Indiana district the International Committee on Service Leadership Programs. Its objective is to strengthen and expand Kiwanis branded programs serving youth and young adults.

Other Important Information:

The Board voted Geneva, Switzerland as the site for the 2011 International Convention (July 5-10, 2011).



## Past Governor Distinguished Service Award

Every New York District Kiwanian now has the opportunity to recognize and honor an "unsung hero", grass roots Kiwanian with the District's highest Distinguished Service Award. If you know of a Kiwanian who works tirelessly and continuously to help your club improve the lifestyle of disadvantaged citizens in your community and is seldom or never recognized for their efforts, you can reward them by submitting their nomination for this prestigious Distinguished Service Award.

The New York District Past Governors Council encourages all New York District Kiwanians to submit recommendations and proposals for nominees qualified to receive the "Gerald P. Christiano Distinguished Service Award" sponsored by The New York District Past Governors Council and awarded annually at the District Convention. The award is intended for the 'grass roots Kiwanian, often overlooked for their continuous dedication, untiring efforts and commitment to the betterment of people in their community who are less fortunate than themselves. Nominations must comply with the following criteria established by the Council March 3,2001.

The award may be presented to only one Kiwanian each year at the annual New York District Kiwanis Convention. The Honoree should be a living New York District Kiwanis member in good standing, who has exhibited outstanding meritorious service to individuals in the community and has contributed in an extraordinary manner over a significant period of years to the advancement of Kiwanis.

Governor-elects, sitting Governors and Past Governors shall not be eligible to be nominated for or receive this award.

Award presentation and expenditures will be financed by the Council only, and cannot be purchased by any club or individual.

Recommendations and proposals for award nominees must be submitted by a Past Governor and shall be presented in writing to the current Council Chairman, not later than **January first** each year. The Council Chairman shall mail a copy of submitted proposals to Council members not later than **February first** each year.

Evaluation and approval of each award recipient shall be by a two-thirds majority vote, by closed ballot of all Council members present at the Mid-Year Conference Council Meeting each year.

The Aktion Club of the Adirondacks was presented the second place award from Kiwanis International in the Single Service Project Award. Here is a description of the project. The club heard about a local soldier from the Adirondacks area who lost a leg in Iraq. The soldier was recovering in Texas and the club contacted his mother. She told them he was lonely, and in pain and needed support. They made a large poster sized card which was decorated and signed by all the members. They made the soldier a gigantic pillow and a fleece with an Army design. The Club Advisor helped the members with the sewing. They delivered the pillow to the soldiers parent's who were going to Texas to visit him. The soldier was so touched by the gifts, he cried when he saw them. Next, the club sent the soldier candy for Valentines Day. He returned home to central New York and is currently attending college. In October 2007, the club sent cards to soldiers at Walter Reed Army Hospital. The hospital returned the cards because specific soldiers names on the cards. The VA Hospital in Bath NY was contacted for help. They had four soldiers with no family contact. So the Action Club forwarded the cards to them. In February 2008 the Aktion Club sent easter cards to the Bath NY VA hospital.

The Aktion Club members learned to share their love and caring with people they have never met. Since many of them grew up in institutions, this concept is one they have not had the ability to develop. Obviously they are doing very well at it.

Publicity is not permitted by the organization that operates the homes where the members live. The Kiwanis Clubs in Saranac Lake and Plattsburgh were told about the efforts of the Aktion Club. This will become on an ongoing project. The Aktion Club members are learning about creativity, caring, and how valuable they are.




kayaks, paddles and personal floatation devices all out and ready to go.



When I was eight years old I asked my Continued on Page 13





#### Symptoms of Lyme Disease in Pets

Symptoms of Lyme disease in animals are similar to the symptoms in humans. Although you will not see a skin rash on your pet, they can experience a range of symptoms.

IN DOGS: Some infected dogs do not experience any symptoms of Lyme disease. Symptoms include lethargy, arthritis (displayed as joint pain, shifting from foot to foot, and lameness), fever, fatigue, and kidney damage. Symptoms can become chronic.

IN CATS: While there is some debate about whether cats suffer from Lyme disease, cats are thought to be highly resistant to the

stricken with pediatric Lyme's Disease so that they may be given a chance to live normal, healthy and happy lives. My grandfather not only took the time to learn, he educated and spark awareness in people about the devastating effects this illness can have on people in their daily lives.

Almost ten years later, I sit nere writing my college admissions essay realizing that through this perfect man, in my eyes, is a man that has saved not only my life, but many other lives, through a foundation that was founded by him. He watched me suffer from this disease that I was born with and misdiagnosed with until I was seven.

This disease is not just debilitating to the patients stricken with it, but the financial burden that it causes families is horrible. What I admire most is that the Pediatric Lyme Foundation's is that it raises money to help relieve the families of some of the financial burdens. They do this through a Brittany Fellowship Award, named after myself, in honor of my grandfather for his dedication to everyone that has unfortunately been diagnosed with any tick born illnesses that needed assistance. Not just financial support, but support in many ways. The support includes counseling, or just by sitting by a family who needed support for a new treatment, or accepting a late night phone call to let them know we know what they are going through and that we're there for them no matter what they

Not many people know how bad this disease may be until you realize that it causes cognitive impairment, excruciating pain, skin rashes, along with many side effects and that not everyone is fortunate enough to enter into a remission state for a long period of time like I have been. Not everybody was fortunate enough to have an amazing grandfather, friend, or support group that I have grown to have.

I have learned that I can be anything I set out for as long as I try not to let this disease overcome me.

The second is designed for sponsored youth. The KPTC Service Leadership Fellowship is available for \$150. This


