



#### **Governor-Elect Candidates**

Now is the time when those of you wishing to run for the office of Governor-Elect make your decisions to officially do so and to notify the District Secretary of your intentions. The time line for notification must be between the dates of January 1, 2003 and May 31, 2003. The District Policies on Campaigning are clear and must be published annually in the E.S.K.

Please accept the following publication of such policies as fulfillment of that requirement

**191.** Campaign Policies for District Office The following policies shall be used in campaigning for an office of the New York District of Kiwanis International.

#### 191.1 Announcement and Publicity

- a. Campaign policies shall be published in the ESK annually.
- b. Candidates for District Office (with the exception of Lieutenant Governor) shall not announce or publicize their candidacy for said District Office until January 1st of the Kiwanis Administrative year of said election and having filed a written statement of intent not later than June 1st with the District Secretary.
- Information for campaigning shall be sent to all candidates and their home clubs by the District Secretary.
- d. The Governor, Governor-elect, Past Governors, District Secretary, District Treasurer and Sponsored Youth Administrators shall refrain from making a public endorsement in connection with any contested District election, specifically Governor and Governor-elect, except when campaigning on their own behalf.
- e. The District Office shall provide a maximum of two (2) sets of mailing labels to the candidates at their expense for the following: Lt. Governors, Lt. Governorselect, Club Presidents, Club Secretaries, District Committee Chairs, Past District Governors and Past Lt. Governors maintained in the District Office database.

#### 191.2 Invitations to Conferences, Conventions and General Campaigning

- a. During the year in which the election takes place, all announced candidates shall be invited by the Governor and/or Governor-elect to attend all Conferences, District Board Meetings and Conventions at their own expense.
- b. Mid-Winter and District Convention site activity should be primarily conducted in or around the convention booth area. Candidates shall assure that campaign supporters and workers do not block entry and exit ways to convention facilities. Each candidate for a District office (other than Lt. Governor) shall be provided a booth at the Mid-Winter Conference and the District Convention. Promotional material and upkeep of the booth, however will be the candidate's responsibility and at his/her expense.
- c. If official Kiwanis stationery is used in a campaign, the present status of the writer/author must be clearly identified. i.e. JOHN DOE PAST LT. GOVERNOR
- d. Active and personal campaigning:
- All candidates shall be responsible for the decorum of their workers and shall accept full responsibility for their campaign finances and appearances.
- 2. Visits may be made to Division functions only by written invitation from the Lt. Governor. If an invitation is extended to one candidate, the Lt. Governor must invite all candidates for the same office. In order to minimize the time and

- expense of campaigns for District Office it is recommended that divisions join together to host a "Meet the Candidate" gathering. It is also recommended that between seven (7) and fourteen (14) "Meet the Candidate" events (either single division or multi-division-sponsored events) be attended by the District Office Candidates.
- If a candidate does attend an official visit for the Governor to a Division other than his/her own, no campaign buttons, no lapel pins, and no attire that would indicate campaigning will be worn. However, private verbal campaigning shall be allowed.
- 4. Nothing should be said or inferred against another candidate.
- No candidate shall solicit or enlist the aid of Kiwanis-sponsored Youth in the campaign.
- e. The list of registered delegates shall not be available to any group or individual before or during the convention for electioneering or other purposes, other than those required by the By-laws and necessary to the conduct of a District Convention.
- f. All campaign material shall be prohibited in the House of Delegates or during any General Session at a convention or conference.
- g. No more than five thousand (\$5,000) dollars shall be used by any candidate or in support of the candidate by other individuals, groups, Kiwanis Clubs or divisions. This includes all costs, both actual and in "like-kind" goods and services used by the candidate's campaign.
- h. Within ninety (90) days of declaring his/her candidacy, the candidate shall submit his/she budget for the campaign to the chairperson of the Campaign Practices Committee. The Committee shall review the budget, accept or recommend changes or ask for clarification of items.
- i. The Campaign Practices Committee, consisting of seven (7) members shall include at least two members of the Past Governors council, two Past Lt. Governors, two current Lt. Governors and the chair of the Laws and Regulations Committee. The Committee shall supervise campaign practices and shall receive, consider and act upon any complaints or violations of the letter and spirit of these policies. The Committee shall report violations promptly to the Governor and the District Board of Directors.

### 191.3 Filing Procedure

The candidate and his/her Treasurer will file three (3) reports of Campaign Receipts and Expenditures with the District Secretary and the Chairperson of the Campaign Practices Committee which shall be regarded as confidential. These reports shall include the retail value of gifts received and expenses incurred whether paid or unpaid:

- First draft sent not later than February 28,
   Not later than ten (10) days before the convention,
- 3. On convention election day by 8:00 a.m. to include all receipts and expenditures up to 10:00 p.m. of the previous day,

### 191.4 Violation of Campaign Policy

Violations of the District's campaign policy shall be handled in the same manner as violations of District policy under Section 111., except when the District Board of Directors, by majority vote, rule there has been an intentional violation of campaign policy. The *Continued on Page 6*

### **East Yonkers/Yonkers Clubs Honor 9-11 Hero**

The Kiwanis Clubs of EAST YONKERS/ YONKERS, Bronx Westchester South Division - joined together to honor local resident, William Van Scoyoc. William was born in Bronxdale and grew up in Yonkers. He is a graduate of St. Eugene's School, Iona Prep and attended Westchester Community College. After a successful financial career with Dean Witter Reynolds in White Plains, William began co-leading the National Sales Training Department for Morgan Stanley Dean Witter at 2 World Trade Center in 2000.

On the fateful morning of September 11, 2001, William helped evacuate 276 people from Tower 2. Some of these were trainees who had only begun the program the previous day. His courage and decisive actions in the midst of the chaos and confusion following the plane crash undoubtedly saved many lives, even as his own was put in peril.

East Yonkers President Palma Volino and Yonkers Past President and LG Elect Rocco Riti assisted PLG Pat Farenga, William's cousin, in coordinating the event which was held at Spiritoso's in Yonkers. About 75 people were in attendance, representing nine clubs in the division.



As we begin 2004, Karen and I would like to thank all of you for the gracious manner and warm hospitality with which we have been received thus far at our Governor's Visits and other functions. We are having a wonderful time, and it is obvious in our travels that you are rendering invaluable service to your communities. Keep up the good work!

We are also very much looking forward to seeing you at our Mid Year Conference from February 27-29, 2004 at the Nevele Grande. It will be a wonderful conference, with substantially reduced room rates and a new front desk staff at the hotel since our District Convention there last year. Our Kiwanis registration fees will go directly to our District, instead of being sent to the Nevele with the hotel registration fee, which should also make for a much smoother operation. Membership Retention plays a major role in a positive growth strategy for any club. How do we keep our members from slipping out "the back door" as quickly as we bring others in through the front? To begin with, we need to understand that club membership is dynamic and variable. It has been estimated that the typical Kiwanis club will gain 15% and lose another 15% of its members in a given year, including some for reasons that are unavoidable, such as death and relocation. We lose most of our members, however, for reasons that are totally avoidable:

- The prospective member who never appropriate Membership Orientation, doesn't understand what the club is really all about, and drops out when he finds it doesn't suit his or her needs.
- The younger member who finds himself or herself left out of the club's cliques and fellowship.
- The member who is hospitalized and receives no get well wishes from the club or any of its members, or whose parent passes away without any expression of sympathy by the club.
- · Most commonly of all, the member who gradually loses interest and wanders away from the club without anyone noticing until it is too late. His or her weekly attendance becomes monthly, then sporadic, and then not at all.

People join Kiwanis in large measure because they want to be a part of a larger family in a community service setting. When the club and its members cease to treat one of their own as family, fail to involve the member in community service projects, and do not provide an enriching club meeting, they look elsewhere for these things.

An eagle carved from wood and a flag stand are in one corner of the garden and another corner holds a marble stone with a plaque explaining the purpose of the tranquil little space next to the school's playground.

District Governor shall announce that fact to the convention delegates before they vote for the office sought by the candidate who committed an intentional violation of campaign policy.

#### 192.0 District Officers and Chairpersons Hold One Position Only

No member, with the exception of the Secretary/Treasurer shall hold more than one District Office or Chairmanship of a Committee activity at the same time, with the exception of those positions where the member is chairman of a committee, ex-officio, by reason of holding a particular office, i.e., Governor, as Chairman of Executive Advisory Committee, and Governor-elect, as Chairman of Achievement Committee. A District Chairman may not serve as District chairman and Zone chairman of the same or another committee simultaneously.
























Membership Growth and Development

A year and a half ago Mike Malark came to me and asked if I could develop a "Membership Growth" training program for the New York District.

Every piece of membership literature we could find from International and the District was looked at. A hands on work book was developed with help from Ann Sewert and John Yanick and was tested at a Finger Lakes Division Workshop. We tested the materials again at the Mid-Year meeting with two workshops and the feedback was overwhelming. Those in attendance all agreed that this was badly needed. This program was designed and developed as a hands on step by step process. If the process is followed, you and your club will have positive results. The workbook includes Membership Growth, Rebuilding Membership, Recruiting -A Membership Campaign, Recruiting, Revitalization, Retention and an Orientation.

Solutions to the N.Y. District growth problems do exist and we now feel that we have the proper tools to turn the growth problems around. Improvements have been made to New Club Building and we are now able to build new clubs when and where needed and we have developed a new method for following - up with the new clubs.

We have also undertaken a new approach to membership growth. The Membership and Development Team is now able to reach out and teach club leaders and membership growth chairpersons the necessary skills to achieve Membership Growth within the area that they live. The New York District had been divided up into 9 Regions and the Membership Team is holding workshops in every area. The Workshops began in October and we have already completed 7 regions. The last 2 Workshops will be held in January.

### **Keys to Success** in the Kiwanis Clubs

- Teaching club leaders the necessary skills they need to make their clubs grow.
- Continually develop and identify the "how to's" that really work to solve Kiwanis Club growth problems.
- The annual club assessment will provide insight into your-club by evaluating its performance and determining the members' expectations. What members value changes over time, so must the member benefits-tangible and intangible. Therefore, it is necessary to conduct the club assessment on a yearly basis. Over time, you will be able to track how your club has evolved to meet the need of the membership and the growth that resulted. In addition to the annual assessment, there are simple things that can be done throughout the year to keep in touch with member expectations, such as informal one-on-one meetings with members and exit inter-





### What can be done to retain these members?

Here are a few suggestions:

- Create a meaningful Membership
   Orientation program, so that your prospec tive and new members are able to make a
   knowing commitment to the club and its
   activities. In this regard. Kiwanis Inter national provides wonderful materials that
   can be customized to your own use. If your
   new members understand what they are
   getting into, they are far more likely to stay.
- Appoint new members immediately to a club committee or upcoming service project or fund raiser. Get them into the game as soon as possible, while their interest is at a high level!
- Maintain proper attendance records, so that your club can easily determine which members are not regularly attending meeting and how long they have been absent. These records will also assist you in determining whom to recognize with Perfect Attendance, Legion of Merit and Legion of Honor awards, each of which is a big boost to the recipient's enthusiasm for continued involvement with your club.

- Appoint a Club Membership Retention Chair, whose task is to organize a group of members to contact others who have missed several consecutive meetings to see how they are doing, encourage them to attend, and if necessary, arrange a ride for them.
- Publish a club newsletter on a regular basis.
   There are many good reasons to do so, not the least of which is that a newsletter makes it possible for members who have missed several meetings to keep informed about the club's activities and upcoming events, making them more comfortable about returning.
- Here's a thought! Provide each member with a Happy Birthday card that they can redeem for a free meal at a regular club meeting. This is intended as a device to encourage the return of members you have not seen in some time, and make them feel good about their club in the process.
- At various times during the year, schedule special events specifically designed to bring back members who have been slipping away: Charter Night; Past Presidents Night; Homecoming Day; and my personal favorite, Turn Back the Clock Night. As it was run during my club presidency, the calendar was set back ten years that night. The meeting was chaired by our president of that year, while I spent the night in my old pledge apron in the back of the room. It was attended by many members who had long been absent, and we all had a great time and a lot of laughs. Most importantly, some of our "no shows" became active in our club again afterwards.

### What can you do to "close the back door" to your club?

If you have not already done so, your club should now send a conspicuously marked "final" written notice to members who have not yet paid their 2003-2004 dues. At your January board meeting or next membership meeting, you should read aloud the list of delinquent members, making sure in advance that the list is current, so as to avoid unnecessarily embarrassing anyone. Members should then be asked to make personal contact with the delinquent members to collect their dues or clearly ascertain that they wish to resign. The best way to do this will usually be to have that member's sponsor contact him or her.

From then until your February Board meeting, the designated contact person should make superhuman efforts to collect that member's dues. In the process, the contact member should also inquire as to whether the delinquent member is having any problems with the club and see whether there is anything that should be brought to the attention of the club to better address that member's needs. Every delinquent member must be contacted personally and there must be follow up until either the dues

are paid or the member has unequivocally stated that he or she does not wish to remain in the club.

Do not assume that a member wants to drop out merely because their dues are long past due. Sometimes they forget to pay. Sometimes they believe that they have already paid. Sometimes they are right to believe it: The club has lost track of their payment! Sometimes they just want some personal attention from the club. Whatever the reason, it is very likely that most of the people who are personally contacted will pay their dues.

Once you have made every conceivable effort to collect these dues and bring these members back into the fold, you must decide whom to drop at your February board meeting. These members should each be sent a letter, on 30 days notice, advising them that their membership will be terminated for nonpayment of dues as of March 31 if they have not paid by then. If they still fail to pay, you should drop them on your 2nd half semi-annual dues statement, but no earlier than that.

From that point on, there should be no further drops, as everyone remaining on your roster will be paid in full for the balance of this year. The last six months of your year should then be devoted to the membership drives and other events (our Membership Team will be happy to provide you with ideas) necessary to finish your year with a net growth in membership, sufficient to meet your club's manpower needs and satisfy your Distinguished Club criteria. Those criteria call for not less than a 3% net increase in members, or a 30% new member add. For example, a club with 100 members (lucky club!) would achieve Distinguished status either by finishing the year with 103 members (3% net increase); or by inducting 30 new members (30% new member add), regardless of the net change at the end of the year.

#### **Directors & Officers Liability**

What if you are personally sued because your club gave a scholarship to one student and not another? Or your club is sued because the state decides your club has violated your charter or bylaws. Perhaps every member of the club is sued because of a sexual harassment claim. Can't happen? Think again!

You as a member of the club can be personally sued for actions or decisions made by the club. And no, your homeowner's policy does not protect you from this.

The largest claim against the Kiwanis Directors & Officers Insurance policy was caused by a violation of club bylaws. The Kiwanis D & 0 insurance policy paid the fine.

Harassment claims are not covered by the Kiwanis International Liability policy but are covered by the D & O policy.

All of us are open to claims and lawsuits simply because we are members of a group. Any day-today decision by anyone in a Kiwanis Club can trigger a claim. The way to protect your club and yourself is to have your club obtain a Directors and Officers Liability Policy.

Kiwanis International offers a policy that costs \$600 for a \$ 1,000,000 limit. The policy runs from November 1st to October 31 each year. Your Club Secretary has the brochure, or call Hylant Group at 800-442-7475 and ask for the Kiwanis desk.

### Membership Growth Workshop Success





#### Sale of Commercial Products

The sale of commercial products is one type of fund-raising activity utilized by many clubs whose members are enthusiastic about selling products. Some commercial products may be available through local or nearby manufacturers or agents. Many commercial products are available from manufacturers in a special organizational fundraising plan containing complete instructions and promotional materials.

Advertisements in each issue of the KIWANIS Magazine offer information on a variety of such fund-raising plans. The August issue of the magazine is the annual fund-raising issue. It is devoted exclusively to fund-raising ideas, and this issue generally carries a large number of fund-raiser advertisers.

Attractively packaged candies and nuts are good sales items, as is citrus fruit, especially in areas where fruit is not grown. Fruitcakes are excellent for holiday gifts, and club members may wish to purchase quantities for their own companies or organizations (some clubs develop a customer list for repeat sales). Popcorn is a product that can be sold at any time of the year or on a continuing basis.

Peanuts for Kiwanis Peanut Day may be obtained from local sources or purchased from national firms such as Kiwanis Peanut Day Inc., 900 Jorie Blvd., Oak Brook, IL 60523. Telephone: 1-888-768-8386. Web address: Kiwanispeanutday.com.

Gum and candy vending machines involves the club's negotiating for location sites and being paid an agreed-upon percentage of the receipts by the company that owns, places and services the vending machines. (Exercise extreme care in selecting a gum machine firm. Beware of highpressure salesmen suggesting that the club purchase a machine, which the club must place and service. The potential return of such an investment should be carefully checked.) More than 2000 clubs are presently using the Fordway Plan. For details, call toll-free 1-800-225-5535, or see their advertisement in the KIWANIS Magazine.

- Choose dates that will not conflict with holidays or other events of community importance.
- •Select the best auditorium facilities or field locations available.
- •Make sure the same type of program has not failed in the community .
- Make sure every part of a contract is clearly understood, and seek legal advice before signing.
- For additional revenue, incorporate solicited ads in the printed program when possible.

### **Circus**

A circus requires careful planning, hard work, and a signed contract. Clubs should be careful if employing professional ticket-selling agencies. Their high-pressure tactics and sometimes unethical methods can create negative public relations and adverse criticism of a club or Kiwanis in general.

For many years, circuses delighted children and their families by introducing them to exotic animals such as elephants and tigers. Today, however, the treatment of these animals is a matter of considerable debate. While some people simply enjoy the enter-

tainment, others feel that the animals are abused by the circus handlers. A Kiwanis club that chooses to host a circus should thoroughly investigate the circus and its history, and the club should make sure it is completely comfortable with the circus' reputation. 
### **Sponsored Performances**

### Kamp Kiwanis Acre Adopted in Memory of Eric Seyfried


